## **Re: “Permission for the Reproduction and Public Transmission of Master’s Theses”**

Master’s theses (hereafter referred to as “thesis” or “theses”) are, through services of the Shonan Fujisawa Media Center (hereinafter referred to as “SFC-MC”), used as a valuable knowledge resource for the promotion of education and research at Keio University. According to the Copyright Act, the SFC-MC must acquire the permission of authors to provide part of its services. Please carefully read the information below before submitting the “Permission for the Reproduction and Public Transmission of Master’s Theses.”

### **Services Provided by the SFC-MC (Basic)**

Applies to all theses.

#### **◆ Making bibliographic information publicly available**

Bibliographic information\* will be added to the university’s library catalog system and made searchable from within and outside Keio University. This includes adding the information\* to the university’s academic theses database systems that are made searchable from the Shonan Fujisawa Campus (hereinafter referred to as “SFC”).

\*Bibliographic information: name of author, title of thesis, number of pages, size, degree, academic year of degree conferral, year of publication, date of degree conferral

#### **◆ Storage and perusal of bound copies of theses**

The SFC-MC makes a bound copy of each thesis by printing the original digital files that the author has submitted to the university. The bound copy will be placed on designated bookshelves in the SFC-MC library for the perusal of library users.

### **Services Provided by the SFC-MC based on Author’s Permission (Optional)**

Only theses for which the authors have granted permission on the “Permission for the Reproduction and Public Transmission of Master’s Theses” will be subject to the following services provided by the SFC-MC.

#### **◆ Reproduction of bound copies of theses**

The SFC-MC makes reproductions of theses and provides them to users approved by the SFC-MC in order to meet their academic research needs. The SFC-MC also makes theses available for check-out to Keio University users approved by the SFC-MC if and when they need it for their academic research.

#### **◆ Open Access**

The SFC-MC adds digital abstracts and/or the complete theses to the university’s academic theses database systems, which are accessible from within SFC. Those viewing the theses may download and print them.

### **【Copyright】**

The “Permission for the Reproduction and Public Transmission of Master’s Theses” seeks permission for the rights to reproduce and publicly disclose theses. The rights to reproduce and publicly disclose works stored at the library are prescribed by articles 31 and 23 of the Copyright Act respectively. Because a master’s thesis is not considered to be a work published in the public domain, the reproduction of even one page of a thesis requires the permission of the author.
