- 1 **The bell schedule for the examinations is different from the schedule for regular classes.** (The timing of the bell also differs between campuses)
- 2 Additions or changes may be made to either the examinations timetable or the criteria for personal belongings.
Please regularly check the Student Website, "News" on keio.jp and "K-LMS".
- 3 Please make sure that you are in the correct examination room. Even though a course may share the same course title and supervisor, examination rooms are separated by day and period. Your grades may not be counted if you are in the wrong examination room.
- 4 The courses listed here are PEARL courses only. For other courses, please check the Japanese version.
- 5 Even when all belongings are permitted in the examination room, students are prohibited from bringing

computers, electronic dictionaries, and devices with communication functionality (Mobile phones, smartphones, tablets, wearable devices (such as smartwatches) etc.).

When checking to make sure where the right examination room is, you can use the following resource to confirm. If you are unclear about the notation used for the examination rooms shown in the timetable, please consult with the staff members in charge of your faculty at the Hiyoshi Office of Student Services.

【Notation of Timetable】

If the examination for a course is due to be held in several different examination rooms, the faculty, year level, and class group of examinees will be stated in the student assigned column so that students are able to identify their examination room.

① Faculty names are abbreviated. In the case of the Faculty of Law, the Department of Law and the Department of Political Sciences will be indicated by the abbreviations of "Law" (法律) and "Politics" (政治) respectively.

[e.g.] Economics, Law, Politics (経、法律、政治) → Students registered at the Faculty of Economics, the Department of Law in the Faculty of Law, and the Department of Political Sciences in the Faculty of Law will, irrespective of year level, take the examination in the specified examination room.

② Information for students who are not registered at the faculty or department of the course, graduate school students, students affiliated with the various research institutes and centers, students enrolled in the Program for Postgraduate Certification of Education

students, Japanese Language Program students, and examinees due to enroll at the university (graduates of the Keio Academy of New York and graduates of Keio's affiliated high schools who have utilized the "Course Registration System before the entering the university for PEARL, the Faculty of Economics", etc.) will be indicated as "Other" (その他).

③ If examination rooms are allocated according to the year level of the students, this will be shown as a number after the abbreviation of the faculty name.

[e.g.] Law 1/2 (法律 1・2) → First- and second-year students of the Department of Law will take the examination in the specified examination room.

④ If there are katakana, letters of the alphabet, or numbers written after the year level, this indicates the student's class.

[e.g.] Commerce 2 E, Ka-Ku (商 2 工・力～ク) → Year 2 students of class E (工), and classes Ka (力), Ki (キ), and Ku (ク) of the Faculty of Business and Commerce (商) will take the examination in this examination room.

⑤ If your subject coordinator's name is noted in the examination room breakdown column, you are requested to sit in the examination room assigned to that subject coordinator.

[e.g.] (Subject Coordinator A) Science 1 A-No (理 1 ア～ノ) → Of the students taking Subject Coordinator A's course Group A (ア) - No (ノ) first-year Faculty of Science and Technology students will sit the examination in this examination room.
