Please see the URL below for further information. https://www.students.keio.ac.jp/en/com/class/registration/other-faculties.html (2) Before registering for courses, check the syllabus carefully, since the course timetable may change, some courses may impose new restrictions on the eligibility of students, or new courses may become available. (3) Attend all classes you have registered and classes you are likely to add until the results of the course registration have been announced. (4) No credits will be given for a course that has not been registered.</p>	
Sep. 30(Thu.) 6:00 p.m.	<p><u>Announcement of the Results of Adjustments to the Number of Registered Students on Courses</u> The number of students may be adjusted when many students have registered for the same course.</p>	
Oct. 1(Fri.)	<p><u>First day of the Fall Semester Courses</u> Regular classes begin.</p>	
Oct. 5(Tue.)	<p><u>Add other courses</u> If students wish to add other courses as a result of the adjustment, read through the announcement to find courses which allow additional registration, and e-mail by Oct. 5. <mita-gakuji-sho@adst.keio.ac.jp> If the courses require the permission from the lecturer, check the notes written in the announcement and obtain permission immediately.</p>

Courses that can be cancelled <u>Cancellation period for the first half of the Fall Semester:</u> courses offered during the Fall Semester and the first half of the Fall Semester <u>Cancellation period for the second half of the Fall Semester:</u> only courses offered in the second half of the Fall Semester</p> <p>B. Courses that cannot be cancelled 1. Cancellation that will affect the requirements advancement/graduation</p>
